

# School Family Engagement Policy

## Stephen F Austin Elementary 2023-2024

### **PART I. GENERAL EXPECTATIONS**

Austin Elementary agrees to implement the following statutory requirements:

1. Austin Elementary will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESSA:

- \* Present the plan at the Title I Meeting
- \* Create opportunities for parents to volunteer
- \* Have pertinent information planned to present at the monthly PTO meetings in order for parents to be informed.

2. Austin Elementary will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESSA:

- \*Policy will be sent home in both English and Spanish languages.
- \*Policy will be presented at the Title I meeting
- \*Policy will be reviewed annually.

3. Austin Elementary will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend by:

- \*Invite parents to the Title I Part A meeting by sending invitations home in folders and posting on ClassDojo.
- \*Austin will offer meetings on different days at different times.

4. Austin Elementary will provide parents information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children 's progress, and the proficiency levels students are expected to meet by:

- \*Providing information on the State's expectations on our campus website and social media for parents.
- \*Giving this information to parents at a monthly parent-principal roundtable forum.

5. Austin Elementary will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

- \*Scheduling parent-teacher conferences on any given day during the teacher's conference period, before school, or after school.

- \*We will also convene 504 meetings as often as needed to help the student.

- \*Bowie has an open-door policy

6. Austin Elementary will provide each parent an individual student report about the performance of his/her child on the State assessment in at least math, language arts and reading by:

- \*Providing results to parents in Monday Folders.

- \*NCLB Report Card and/or School Report Card will be provided to parents.

- \*All testing; including common based assessments and benchmark test scores will be communicated to the parents.

7. Austin Elementary will help parents of children served by the school, as appropriate, in understanding topics such as:

- \*the state's academic content standards,

- \*the state's student academic achievement standards,

- \*the state and local academic assessments including alternate assessments

- \*how to monitor their child's progress, and

- \*how to work with educators

8. Austin Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

- \*PTO meetings

- \*Meet the teacher night with curriculum training and resources provided to help our parents

- \*Utilizing the EISD Parent Resource Center and Parent Liaison

9. Austin Elementary will , with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

- \*Parent/ Teacher conferences
- \*Site Based meetings
- \*Utilizing the EISD Parent Resource Center and Parent Liaison
- \*Bowie school programs and performances
- \*PTO meetings

10. Austin Elementary will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Give a Kid a Chance, Parents with P, campus parent nights, and other programs. The school will also conduct other activities that encourage and support parents in more fully participating in the education of their children, by:

- \*Specific grade level parent/ teacher/ student meetings
- \*EISD Parent Resource Center trainings with Parent Liaison
- \*PTO meetings

11. Austin Elementary will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable , in a language the parents can understand:

All correspondence between school and home will be in both English and Spanish  
All meetings and programs will have a translator  
Parents are invited to be an integral part of our PTO
