\$2,500 per semester

- Your enrollment must be a minimum of 12 hours per semester, the majority of which shall be applicable to the degree plan.
- The scholarship will not exceed the sum of \$20,000 over a five-year term, payable at \$2,500 a semester to the school for tuition.
- A grade point average of 3.2, based on a standard 4.0 grading scale, must be maintained to continue eligibility for the scholarship.

Community Scholarship Requirements

\$2,500 One Time Award

- This scholarship will be a one-time award of \$2,500 for books and tuition.
- This scholarship can be used to pursue a business degree or a degree in another field.
- The check will be payable to the school.
